What does the cover include?

Here is a summary of the key elements available to Angling Trust members. A full policy wording is available on request.

Public liability

- ◆ Up to £10 million.
- ◆ £250 excess.
- ◆ Limited Marine extension (applicable to Club & Fishery membership only) – excludes any chartered vessel or watercraft and any watercraft which is more than eight metres in length. Please refer to the policy documents for full cover details.
- ◆ Up to £2.5 million abuse extension in the aggregate – excludes defence for criminal proceedings.
- ◆ Territorial limit is Worldwide excluding USA and Canada.
- ◆ Public liability covers members of the Angling Club whilst fishing at the club's water or on behalf of the club at other fishing events.
- ◆ Policy covers work parties for clearing and maintenance of the waters including the use of chainsaws.

Professional indemnity

- ◆ Up to £10 million in the aggregate.
- ◆ Nil excess.
- ◆ Territorial limit is Worldwide excluding USA and Canada.

Employers Liability

- ◆ Up to £10 million.
- ◆ Territorial limit is Worldwide excluding USA and Canada.

Directors & Officers Liability and Corporate reimbursement

- ◆ Up to £5 million in the aggregate.
- ◆ £250 excess.
- ◆ Policy covers trustees.
- ◆ Territorial limit is Worldwide excluding USA and Canada.

Property

- ◆ Up to £2,000 club equipment covered anywhere in the UK.
- ◆ Up to £500 club trophy cover.
- ◆ Up to £25,000 cover for fish stock arising from storm, malicious damage, theft or death by Koi Herpes Virus (KHV) and Spring Viraemia of Carp (SVP), providing that the safeguards and preventative measures are in place as outlined in the policy schedule. £5,000 loss of income/revenue in respect of losses following damage to fish stock.
- ◆ £250 excess.
- ◆ We can arrange an additional policy for any extra covers including buildings & contents at club/fishery premises.

Personal accident

- ◆ Capital Benefits: The percentage of this amount which is £5,000.
- ◆ The benefits payable will be the following percentage of the capital benefits specified above.
 - 100% Death of insured persons aged 18 years and over. Death of insured persons aged less than 18 years is 20%.
 - 100% Total and irrecoverable loss of all sight in both eyes and/or total and irrecoverable loss of use of both hands or feet or one hand and one foot.
 - 50% Total and irrecoverable loss of use of one hand or one foot together with total and irrecoverable loss of sight in one eye.
 - 25% total and irrecoverable loss of all sight in one eye or total and irrecoverable loss of use of one hand or one foot.
 - If the insured person becomes totally and permanently disabled as a result of injury sustained whilst travelling to or from an event in which they are engaged to play for the Insured, we will pay 20% of the applicable capital benefits shown on the policy schedule.
- ◆ Extension: Loss of income caused by illness by Weil's Disease (Leptospirosis). Section limit £50 per week. Loss of two eyes £50 per week up to a maximum of 52 weeks. An excess period of the first 14 days applies.
